The adopter read carefully all information stated in this contract. She/he is aware that given behavior of the animal wes demonstrated at OZ Útulok Skalica and might change in the future, according to the conditions the animal will be kept in. The adopter is aware of the stated above and takes over full responsibility of the animal.

II. RIGHTS AND RESPONSIBILITIES OF THE PARTIES

1/ The animal cannot be held on chain without access to open space for a long period of time. It must have access to fresh water, space to move and must be fed at least once a day with sufficient amount of suitable food. It must be treated with respect and love in any circumstances.

2/ The adopter becomes fully responsible for the day care, health treatment that the animal will need, as well as for all the damage caused by the animal. The adopter takes full responsibility for the veterinary costs.

3/ The adopter guarantees that she/he will provide an animal – the dog with chip containing her/his address from the veterinary practiotionner, regular chip exchange and vaccinations as required by law and she/he will not allow for move in public without supervision.

4/ The adopter is obliged to comply with the provisions of the Veterinary Care Act and the applicable decrees (now 39/2007 Coll., 123/2008 Coll.) and all laws of Slovak Republic relating to the keeping of pet animals, as well as general laws and valid general binding regulations.

5/ In case the animal had not been sterilized or castrated, the adopter must in all cases prevent any other breeding of the animal. It is mandatory to provide sterilization / castration of the animal after reaching 1 year of age and declare this by veterinary report to OZ Útulok Skalica personally, by post or by e-mail.

6/ The adopter must report to OZ Útulok Skalica loss, death or change of address of the animal.

7/ OZ Útulok Skalica will provide to the adopter all the known information about the animal, even though at times not all the facts from the past are known to OZ Útulok Skalica.

8/ The adopter will enter in contact with OZ Útulok Skalica at least every 6 month during the first three years, counting from the day the animal was adopted. She/he will inform the organization by phone, e-mail (with attached pictures) or personally about the animal and its state.

9/ In case of family houses or residence with access to garden or yard, the adopter is obligated to secure the surroundings so they do not become a threat to the animal's life (i.e. another dog, bad fence or neighbors). In case the animal is let outside of the house, the warmed shelter must be provided.

10/ The adopter guarantees that in case she/he is not able to keep the animal, she/he will immediately inform OZ Útulok Skalica and will return the animal to the organization, if the parties do not agree on different conditions. In case of restoration, the adopter cannot claim any financial compensation for the incurred costs she/he had for adoption and care of the animal. It is obligatory to return the vaccination card as well. In case of abandonment of the animal, legal proceedings will be commenced in accordance with the provisions of the Act of the National Council of the Slovak Republic no. 39/2007 Coll. about veterinary care.

11/ The adopter will receive the vaccination card of the adopted animal.

12/ Situations, such as neglected care, animal abuse, or keeping the animal on the chain, will be reported to Regional Veterinary and Food Administration and the adopter will face legal charges. In such cases, OZ Útulok Skalica has the right to demand retrieval of the animal back to its care without cost compensation.

III. FEES

13/ Upon the adoption, the adopter is obliged to pay adoption fee to OZ Útulok Skalica. The fee consists of costs provided while vaccination / worming / castration and chipping.

IV. SANCTIONS

1/ In case the adopter does not inform OZ Útulok Skalica about change of the state of any data of the animal, she/he can be penalized with fine up to 50 EUR.

2/ In case the adopter does not react within 1 month to written appeals of OZ Útulok Skalica and will not declare the veterinary report about sterilization / castration or will not inform about the state of the animal or change of address, she / he will be charged with contract fee up to 50 EUR, repeatedly if needed.

V. PARTICULAR PROVISIONS

1/ The adopter pledges to treat the animal well and accepts all the responsibility for the animal.

2/ The adopter pleads, she/he has read the contract carefully and understands all its parts, declaring this by her/his signature.

3/ This contract becomes valid the moment it is signed by both parties.

4/ This contract is provided in two copies. One for the adopter and one for OZ Útulok Skalica.
